a) 2022-27 Dock System at the Aus Hunt Marina

Recommendation:

That Council pass by-law 2022-27, being a By-Law to enter into a contract with Kropf Industrial for the supply and installation of a new floating dock structure along the sheet piling at the Aus Hunt Marina in response to RFQ process 2022-03.

Background:

- Replacing docks along the sheet piling wall at the AHM is part of a project initiated last year (2021), which included the new sheet piling along the West side of the AHM basin.
- This project was partially funded (75%) through the FedNor Tourism Relief Fund (TRF).
 Purchase and installation of the replacement docks represent the final component of this project.
- Billings RFQ 2022-03, an RFQ seeking the supply and installation of floating docks for this location, was issued in March of this year. It was targeted to seven (7) commercial dock suppliers.
 - Three (3) suppliers expressed willingness and ability to supply this year (2022) and attended site visits.
 - Two suppliers, Kropf industrial and Dock Kings (King Industrial) provided quotes, although Kropf Industrial was the only supplier that used the quote form. Kropf also voluntarily attended a 2nd site visit, which was necessitated by the need to further refine the specifications of the installation.
- In addition to dock suppliers being busy, there were challenges associated with clearing/finalizing this RFQ process. This included, but was not limited to the following realities:

- Ice out was a little later this year, and the Lake Huron level is down again significantly, so we were a little delayed in getting a good view of the situation.
- We also needed some further consideration and some creative thinking on what would work best in the space available. The re-consideration about what could/should be done at the location was undertaken after the release of the RFQ, and with input from both the former Treasurer (and person responsible for marina operation for years), Bruce Mercer, and the current Marina Manager, Jim Fowlie. The AHM launch ramp was left in place, so we need to keep this launch site as functional as possible.
- It is important to note that the recommended quote exceeds the dock component budget of the project by approximately \$11,500. However, in the opinion of staff, the dock array as spec'd, laid out, and costed, represents a dockage situation on the sheet wall that equals what was there before in terms of # of slips, and significantly exceeds what was there in terms of quality and it also improves the utility of the launch ramp. The system, as depicted and spec'd, should provide a robust and flexible solution for that portion of the Aus Hunt Marina.
- It is also important to note that the original costing on new docks as a component of the AHM sheet piling project was completed nearly a year ago. Given the cost inflation that has occurred during the past year, across the board, this cost over-run is worthy of consideration, especially since it allows for maximizing the utility of the marina space in this location.


