COUNCIL REPORT

Title: Old Mill Road Waterline Cost Recovery Department: Treasury Date: November 7, 2023 Report Number:TR-2023-11-15 (amended) File: Old Mill Road Waterline Cost Recovery Attachment: Optional Excluded Expenses

Recommendation:

THAT the Township of Billings Council hereby approves Report 2023-11-15 AND directs staff under Section 391 of the Municipal Act to bring forward a Capital Cost Recovery Report and associated Draft By-Law based on Option 1 Cost Recovery AND FURTHER outline financing options including length of term and interest rate.

Background:

In 2022, the Township of Billings approved the removal and replacement of the Old Mill Watermain within the right-of-way of Old Mill Road for approximately 850 meters. The watermain is part of the Kagawong distribution system and the project benefits approximately 20 properties.

The project was approved under the ICIP Green Stream funding which covered 73.33% of the project with the remaining 26.67% portion being municipal and eligible for capital cost recovery.

Discussion:

All properties within the Township do not have municipal water supply. The properties that have municipal water are responsible for the costs of operating the system. The associated expenses are not spread over the entire tax base.



There are options available for municipalities to recover capital costs associated with capital water upgrades for benefiting property owners. This can be done on a capital cost recovery method or by a Major Facilities Charge should the municipality have a policy in place.

The Township of Billings does not have a Major Facilities Charge Policy and has traditionally used a Capital Cost Recovery method for funding the Kagawong Water System capital improvements.

There are three main options available for municipalities for Cost Recovery:

1. The passage of a Capital Cost Recovery By-Law under the fees and charges provisions of Section 391 of the Municipal Act;

2. The passage of a Special Services By-Law under Section 326 of the Municipal Act or;

3. Local Improvement Charges in accordance with Ontario Regulation 586/06

The capital cost recovery method has been used by The Township of Billings in the past to finance the Kagawong water system, with examples below.

For the Old Mill Road Watermain project the capital costs are for the removal and replacement of the waterline. A benefiting property is a property adjacent to the Old Mill Watermain replacement project who currently derives or may derive a benefit from its construction.



There are 20 benefiting properties on the Old Mill Watermain project. Attached is a copy of a map showing the benefiting properties.

In consultation with the Municipal Solicitor, staff is recommending the passage of a Capital Cost Recovery By-Law under the fees and charges provisions of Section 391 of the Municipal Act to recover the municipal portion of the waterline project. Under Section 391 of the Municipal Act, municipalities can pass a by-law to impose a fee for capital costs related to sewage or water services on a class of persons who will receive a benefit. The by-law does not have to be based upon frontages or assessed value, the municipality can impose a flat fee and equal fee on benefiting properties.

Option 1- The passage of a Capital Cost Recovery By-Law

Council could opt to exclude expenses considered a benefit to more than just the benefiting property owners including: concrete curb and gutter, guardrail, asphalt, line painting, bridge repair, road signage, culverts, slope stability and geotechnical study.

<u>Option 2</u> – Special Services By-Law under Section 326 of the Municipal Act <u>Option 3</u> – Local Improvement Charges – Ontario Regulation 586/06 These methods are based on assessment and are not considered viable options in this particular capital cost project.

Should Council move forward with either Cost Recovery By-Law option, staff recommend that payment options be considered to spread the costs over a length of time to not impose undue financial hardships on the property owners. For example, 20 years, at a low interest rate 4% and that the payment be paid in the same manner as taxes.

Mr. Steve Watt, Municipal Solicitor for the Township of Billings will be in attendance at tonight's meeting to explain the cost recovery method and answer any associated questions.



Financial Impacts: <u>Option 1</u> Township properties (6) = \$134,805.30

Total \$134,805.30

<u>Option 1a</u> Township properties (6) \$62,399.22 Excluded expenses \$241,353.67 Total = \$303,752.89

The expense for the Township is significant in both cost recovery methods. For Option 1a, consideration must be given to both the past cost recovery method and setting precedent for any future water capital projects.

**Amended Note: further costing was received after the agenda was published increasing the optional expenses to exclude, in effect, reducing the total cost recovery per property for option 1a.

BY-LAW NO 2023-108

BEING A BY-LAW TO CONFIRM THE PROCEEDINGS OF THE COUNCIL OF THE TOWNSHIP OF BILLINGS

WHEREAS the Municipal Act S.O. 2001, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS the Municipal Act S.O. 2001, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under Section 9; shall be exercised by By-Law;

AND WHEREAS The Council for The Corporation of the Township of Billings deems it expedient that the proceedings of meetings of the Council be confirmed and adopted by By-Law;

NOW THEREFORE the Council of The Corporation of the Township of Billings enacts as follows:

- 1. THAT the actions of the Council of The Corporation of The Township of Billings at its Council Meeting held on November 7, 2023 in respect to each report, motion, resolution, or other actions recorded and taken by Council at its meetings, except where the prior approval of the Ontario Lands Tribunal is required is hereby adopted, ratified, and confirmed as if all such proceedings were expressly embodied in this By-Law.
- 2. THAT the Mayor and CAO/Clerk, or such other official as deem appropriate are hereby authorized and directed to do all things necessary to give effect to the said action, of Council of the Township of Billings referred to in the proceeding section.
- 3. THAT the Mayor and CAO/Clerk are hereby authorized and directed to execute all documents necessary on behalf of the Council and to affix the corporate seal of The Corporation of The Township of Billings to all such documents.
- 4. THIS By-Law shall come into full force and effect upon final passage.
- 5. THIS By-Law may be cited as the "November 7, 2023 Confirmatory By-Law".
