5. Delegation

Dan Moody, A.Sc.T. Project Manager Tulloch Engineering RE: Firehall Project Mr. Moody provided some background information on the project getting to the tender stage, and the construction progress until the point when the structural concerns were noted.

Mr. Moody explained that once the interior drywall and wood strapping were removed the cracking was discovered. He noted that the structural issues stem primarily from cracking within the masonry block walls that has developed primarily due to the expansive forces of rust developing on the loadbearing steel lentils over the windows and doors.

He explained due to the unique architectural face on the concrete blocks, these issues were not apparent from the exterior during the design process. It was only once the interior drywall and wood strapping were removed that the cracking was discovered.

Mr. Moody clarified that although drywall and wood strapping are not intended to contribute to the overall structural integrity of a building, they do serve to provide a significant amount of stiffness to the wall assembly.

In addition, Mr. Moody noted that the exploratory work that occurred at the front of the building at the overhead doors required the partial removal of the top panel of an overhead door. This changed the behaviour of the applied wind forces acting on the building.

Mr. Moody presented two options for Council to consider moving forward.

Option One - Short term stabilization, followed by temporary shoring of the roof structure on the affected side of the building. The existing masonry block wall would be systematically removed from top to bottom and disposed of. A new wood frame loadbearing wall would be constructed in place of the masonry block. The new windows, doors, insulation, and siding would then be installed in this newly constructed wall assembly. The movement that the block walls have experienced in their compromised state, has impacted some of the mortar joints on the exterior of the building. These mortar joints on the front and back will need to be repaired. It was identified that the masonry block walls are filled with asbestos containing vermiculite insulation. Removal of the block wall must be completed by a licensed abatement contractor.

Option Two Complete demolition of the building down to the level of the foundation. As the current contract includes for replacement of all siding, insulation, windows, doors,

electrical and mechanical systems these materials could be used. The construction of a new building would afford the opportunity to change the aesthetics of the building. Although the basic footprint cannot change, due to foundation and site constraints, a new sloping roof could be installed to better blend in with the surrounding properties. It has been determined that the structure could be constructed from readily available wood framing members.

Mr. Moody concluded with noting that the repair the existing structure would require significant costs for stabilization, shoring, as well as repairs to the existing masonry structure. For the demolition there would be significant costs due to the hazardous nature of the block fill. If consideration were to be given to complete replacement, the demolition process could take on a completely different sequence. The material would still need to be disposed of as hazardous waste, but the process to do so would be far less labor-intensive.
