By-Law Reminders

On December 7th, 2021 the Township of Billings passed a new trailer bylaw that addresses the use of recreational trailers within the Township of Billings. The new trailer bylaw introduces a fee/permit structure process for persons who will be wanting use recreational trailers on vacant properties, properties with seasonal residences and properties with permanent residences. Public Works Reminders

Council passes a Winter Maintenance Plan each year and is posted on the website under Public Documents. This plan details each road in the municipality by class and therefore its associated snow removal timeframe. We strive to surpass these standards. This plan also details road salt and sand like the fact that winter sand freezes to the point of being ineffective, and problematic to our sanding equipment, at temperatures of -6°C or colder. Many details are taken into consideration when creating this Winter Maintenance Plan, take a look!

General Updates/Project Updates/Grant Applications

An application has been submitted to the FedNor Canada Community Revitalization Fund for improvements to the outdoor rink. These improvements include new professional rink boards, new player benches and stairs, new lighting and a cover. The Township has been successful with their application and will proceed with this work in 2022!

An application has been submitted to the FedNor Canada Tourism Fund for waterfront development at the Aus Hunt Marina. Some work included in the application is new sheet piling and maintenance of the existing boat launch, and new docks on the west side of the Aus Hunt Marina.

Township Staff have submitted an application to the Trillium Community Building Fund to replace the pedestrian bridge on the Kagawong River Trail and as per a recent announcement have been successful in their application! This project will start and finish in 2022! *Please remember the old bridge is unsafe and out of order and will be removed in the future.*

The Township of Billings has been awarded \$100,000, funded in part by the Government of Canada's Enabling Accessibility Fund, for accessibility improvements at the main entrance of the Old Mill Building. These funds will go towards the purchase and installation of new accessible doors and ramps to the Municipal Office and Old Mill

Heritage Centre. Staff are currently working on drafting an RFP for the Engineering and Construction of a new accessibility ramp and doors at the Old Mill Heritage Centre which will be issued in 2022!

Township staff have submitted an application to replace the Old Mill Road waterline with the announcement of a second intake for the Investing in Canada Infrastructure Program (ICIP).
